Pledge of Allegiance was recited.

Clerk, Robert Krohn swore in all township officials for their 4 year term: Larry Krohn – supervisor, Jeanette Renn – Treasurer, Tom Ziel— Trustee, Kevin McKenzie –Trustee. Supervisor swore in Robert Krohn as Clerk. Robert Krohn, Clerk appointed Carolyn Krohn as Deputy clerk, Jeanette Renn appointed Gregg Renn as Deputy Treasurer.

Meeting was called to order by Supervisor Larry Krohn.

It was moved by Tom Ziel, supported by Jeanette Renn, that we approve the agenda, motion carried.

Treasurers' report was given, approximately \$54,417.00 on hand in the General Fund.

Fire chief reported the largest turnout for the annual Christmas party at the fire hall. Chief reported on Nov 2 false alarm, on 18<sup>th</sup> fire at the Bud Posade residence, leaf fire, 19<sup>th</sup> and 20<sup>th</sup> 2 downed wires in the township, and 21<sup>st</sup> tractor and implement went into ditch on Richardson Rd, also presented bills. After discussion it was moved by Robert Krohn, supported by Jeanette Renn that we appoint Jim Seley as fire chief for another 1 year term, motion carried.

No site permits issued for the month.

Supervisor reported that Exelon will not be replacing the turbine that came down, the site will be cleared and put Back to farming.

Margo Barry commented that she would like to see the Township support the moratorium that the county is having a hearing on Dec 14, 2016 at the Expo Center, all board members are urged to attend.

Supervisor reported that the Huron County MTA meeting will be held at the Pigeon District Library on Dec 21, 2016 at 6:30 pm, cost \$12.00 per person.

Clerk reported that there will be an election recount.

Supervisor is looking into prices for the Township for garbage and recycling pickup, will report back later to the Board.
