

Regular Meeting of the Oliver Township Board March 7, 2017

Pledge of Allegiance was recited.

Meeting called to order by Supervisor Larry Krohn.

Members present: Larry Krohn, Jeanette Renn, Tom Ziel, Kevin McKenzie, absent Robert Krohn.

It was moved by Tom Ziel, Supported by Jeanette Renn that we approve the agenda, motion carried.

It was moved by Jeanette Renn, supported by Tom Ziel that the Feb 7, 2017 consent agenda(minutes) be approved, motion carried.

Treasurers; report was given approximately \$818,358.00 on hand in the general fund. Clerk has received a check for \$70,226.62 for the Personal Property taxes for the township.

Fire Chief reported 6 firemen went to Alabama to look at a used fire truck, they looked at a 2011 rescue truck, fire chief signed a sales agreement to hold the truck that has 7900 miles on it and approx 800 hours. Supervisor reported that the Board will do a little more checking within the next couple of days before making a decision on purchasing this truck. Chief reported that the pumper truck has a leaking air boot and has been repaired this week at Osentoski's. Chief Seley reported they have an agreement with Towers to supply water in case of emergency. Chief reported on Feb 22. one vehicle P.I. accident on Stein rd. the person had no insurance.

No Site permits.

Discussion on the hall walkin doors, no new infor at this time.

Who is going to the convention, Larry for sure, maybe Tom , Kevin and Robert & Carolyn.

No report from ITC or any wind company, will attend next months meeting.

Public comments: Randy Haley thanked the Township for helping fund the York ST Project, Margo Barry spoke on the turbine survey she thinks the survey was misleading by not including the Villages survey, done at a later date. Question was asked why the ITC lines are going where they are going. Sally Kain thinks we have enough. Adam Herford supports wind turbines, examples trucks are not bringing out mud onto the roads, turbine drives are very useful in farming practices, wind companies need to be held more accountable. Margo Barry ask if anyone has heard from Exelon about shadow flicker issues, Tom Ziel will make a phone call.

Supervisor discussed the road commission estimates for 2017, average road will cost approx \$150,000.00 per mile, also the Board will meet with the road commission, On March 22, 2-17 at 9:00 am.

It was move by Tom Ziel, supported by Kevin McKenzie that the township sign the ambulance contract with the village, price \$5.00 per person equals \$7415.00, motion carried.

Brion Dickens planning Commission chairman reviewed various zoning changes the board is making, also read the comments from the County planning commission from Jeff Smith.

Commissioner, Steve Vaughn reported the State of Michigan will not be releasing any property out of the P.A.116 agreement for solar farms, not ag related. No recorded solar leases in Huron County at this time.

No assessor report, Board of Review will be meeting next Monday and Tuesday 13<sup>th</sup> & 14<sup>th</sup>.

The budget hearing is set for March 28<sup>th</sup> at 7:00 pm.
