

REGULAR MEETING OF THE OLIVER TOWNSHIP BOARD July 11, 2017

Pledge of Allegiance was recited.

Meeting was called to order by Supervisor Larry Krohn.

It was moved by Jeanette Renn, supported by Kevin McKenzie that we approve the agenda, motion carried,

It was moved by Tom Ziel, supported by Kevin McKenzie the June 6, 2017 consent agenda (minutes) be approved, motion carried.

Treasurers' report was given, approximately \$514,895.00 on hand in general fund.

Fire Chief reported on 2 PI accidents, 1 Laker School false alarm, 2 assists, 1 dumpster fire and 1 lift assist with ambulance, also presented bills.

Old rescue truck has been sold for \$2000.00. Jason Lemont reported on what he has been doing with the fire department and presented his bill for the last 2 months work. After paying Jason \$4000.00 on the original contract, he is willing to forgo the remainder of the contract and work on a consultant basis for the fire department.

No site permits were issued.

Fire hall roof will be inspected and checked out by a local roof installer.

Audit is in process.

It was moved by Jeanette Renn, supported by Tom Ziel that we remove a parcel of land containing 1.15 acres, including shed and house from PA ii6, also accepting 2 parcels of land into the PA 116, a 40 acre parcel and a 20 acre parcel located in Oliver Township, section 16 and 3, motion carried.

Supervisor reported a Board of Review meeting will be held on July 18, 2017 from 9:00am-10:00 am. It was moved by Robert Krohn, supported by Kevin McKenzie that the following will be done, replacement of tube on Geiger Rd $\frac{3}{4}$ mile west Grassmere at a cost of approx. \$6700.00, washouts on Maxwell will be paid for by road commission. Approx \$23,000.00 will be spent of Stein Rd along south side of the dairy setup, motion carried.

Petition is being circulated to stop zoning changes.
