

# September 6, 2022 Oliver Township board meeting minutes.

Unapproved.

Supervisor Tom Ziel called a meeting to order at approximately 7 PM in the township hall.

Motion by Bob Ross and seconded by Kevin McKenzie to approve the agenda. Motion passed.

Fire department members will receive Narcan training. Narcan is a drug overdose antidote. Training will be conducted at the fire hall.

Several of the Fire Department members will participate in a suicide prevention walk at Laker school on the 15th of September.

Tom Ziel reported that we are still waiting for the doors on the fire hall to be repaired.

Tom Ziel reported that Apple Blossom and Exelon wind turbine companies did not agree with the MREC settlement that DTE accepted. There will be ongoing meetings to make a settlement.

Angela Guza gave a brief presentation about her assessor experience and expressed interest in working for Oliver Township. Motion by Adam Herford to hire Angela as Oliver Township Assessor at a pay rate of \$15 per parcel and \$2500.00 sign-on bonus. There are currently 1203 parcels in Oliver Township. Motion passed.
